I declare that this boat has a current valid measurement certificate and I understand that this entry is only valid for the declared helm above.

**Legal Liability:** By signing this form participants accept that they are responsible for themselves, (their crews), and their boats, whether afloat or ashore. Nothing done by the organisers, Emsworth Slipper Sailing Club, The Race Management Team, patrol craft, etc, will relieve participants of their responsibilities. By launching (or putting to sea), participants imply the suitability of their boat and the competence of the skipper (and crew) for the expected or forecast conditions. The provision of patrol craft does not relieve participants of their responsibilities.
